#### **After Greeting:**

Based upon the Provisions of “**The Act of Disclosure and Transparency for Entities Which are Subject to the Syrian Commission on Financial Markets and Securities’ Control and Supervision**” No (110) which was dated on 24/4/2019;

Please to work upon providing – us with the following:

- 1)** The Quarterly Financial Data in accordance with the stated by the Provisions of the Articles (6+7) of “ **The Act of Disclosure and Transparency**” which is mentioned above, an in an exceptional manner within an extreme due date of Tuesday which will be dated on 14/6/2022.
- 2)** The Disclosure Form No (2) which is related to the Quarterly Financial Data and will be published with the related Disclosures on the Commission’s Web-Site.
- 3)** A draft Copy for the Financial Data, and the Disclosure Form No (2), wherein the publishing will be done only for the Form on the Web- site of the Commission until the Accrediting process for the Accountings’ Auditor is done successfully, whereas the publishing of the complete Financial Data will be done which are attached with the Report of the Accountings’ Auditor. And this case will be applied on the Companies that have not held – up yet their meetings of their General Assemblies, nor they have elected their Accountings’ Auditors as well for the year 2022.
- 4)** A Paper copy for the Required disclosures and the Form No (2) in addition to electronic copies in the Form of /PDF/ for both of them, within a sealed envelope which will be titled as the following:

**SCFMS, The Disclosure Directorate, The First Quarter Disclosures** which are dated on 31/3/2022 stipulated for the volume of the Electronic Financial Data not to surpass (5) Five Mega Byte.

And all such will be attached with an Electronic Copy in the Form of “EXCEL” for the Financial Lists of the Company which will be specific for the Internal Use of the Commission.

- 5) All the Companies that have held – up their General Assemblies’ Meetings for the year 2022, must provide us with a certified copy of their Minutes’ Meetings from the Ministry of Consumer’s Protection and Interior Trade to be published on the Web- site of the Commission.

Please to abide – by the abidance with the over mentioned period under the responsibility of imposing the Fines and Sanctions which were stated in the **Article (7)** of “**The Act of Verification and Execution** “No (66)/M for the year 2011.
